

ACACIA MARKETPLACE SHOPPING CENTRE VISA GIFT CARD COMPETITION TERMS AND CONDITIONS



Please read these competition rules carefully. If you enter one of our competitions, we will assume that you have read these rules and that you agree to them.

1. To enter a competition you must be: (a) an Australian Resident; and (b) 18 years old or over at the time of entry. If you are not 18 the prize will be awarded to your parent or guardian.
2. Competitions are not open to employees (or members of their immediate families) of Acacia Marketplace Shopping Centre or any tenants or contractors of Acacia Marketplace Shopping Centre.
3. Competition Entry Requirements, Customer's must:
 - a. Spend a minimum of \$10 at any of our specialty retailers; or \$30 at our Corporate tenants (Woolworths, Chemist Warehouse, ALDI, Supercheap, mycar, BWS, Woolworths Caltex Petrol)
 - b. Take a visible photo of your receipt clearly showing the date, business purchased at and final amount paid. Email photo to info@acaciaplace.com.au along with your name and contact phone number
 - c. The receipt must be dated within the competition dates of 17th March 2020 to 1st April 2020, inclusive
 - d. One (1) entry per store, per day. This means that only one (1) receipt will be accepted per store valued \$10 or over (\$30 for our corporate) each day.
 - e. A customer can spend the required at multiple stores in a day to qualify for additional entries.

Example of qualifying entries:

- a) Spend \$70 at Corporate Store = 1 entry
Spend \$12 at Specialty Store = 1 entry

Therefore, if these purchases were made on the same/different day, the participant will qualify for two (2) entries.

- b) Multiple entries can be made in a day only if they have met the one (1) entry per store, per day requirements.

For example:

On 17/03/20 a customer spends the following:

1. \$50 at Chemist Warehouse (Corporate)
2. \$30 at BWS (Corporate)
3. \$20 at Pho Lewis Tran (Specialty)
4. \$40 at ALDI (Corporate)

This will give the customer a total of 4 entries.

- c) Combined receipts will only be accepted if purchased on the same date.

For example:

\$9 at Fatima's Kitchen 23/03/20

+

\$8 at Fatima's Kitchen 23/03/20

This equals one (1) entry

4. Unqualifying entries will not be accepted.

Examples of unqualifying entries:

- a) Spend \$25 at Corporate Store = no entry
Spend \$9 at Specialty Store = no entry

(Participant did not meet the minimum \$30/\$10 requirement)

- b) A customer is not allowed to combine their receipts from different retailers to equal \$10.

For example:

Bargain Mania \$3 + Bakery \$7 = NO ENTRY

The \$ value requirement must be spent in the one store, on the same day.

- c) A customer is not allowed to separate their receipts in order to gain multiple entries.

For example:

\$10 at Charcoal Chicken on 19th/03/20

\$10 at Charcoal Chicken on 19th/03/20

This will only equal one (1) entry.

5. The last accepted date printed on the receipt will be 1st April 2020.

6. Email submissions of receipts within the valid competition dates will be accepted up until 11.59pm Friday 3rd April 2020, and Acacia Marketplace

Shopping Centre reserves the right to amend the competition end date at any time.

7. There will be two (2) Winners.

8. All winners will be sent an email within 2 working days of the draw.

9. The judges' decision will be final, and no correspondence will be entered into.

10. By entering the competition the winner agrees to participate in such promotional activity and material as Acacia Marketplace Shopping Centre may require.

11. The prize will not be transferable to another person.

12. No part of a prize is exchangeable for cash or any other prize.
